Camaraderie Foundation produced both long term and short term results for our community. For the families participating in the counseling program, the results are long term. Nearly 70 private counseling scholarships (12 sessions each) were awarded in 2012. The counseling affords the participants to learn better coping mechanisms, enhance their communication, and build a stronger family bond. Approximately 50 percent of scholarships were for military servicemembers or veterans; 26 percent for military spouses, and 24 percent for children of servicemembers of veterans. In an effort to help spouses and family members better understand and offer support for their loved one (servicemember/veteran), Camaraderie Foundation provided six counselor led peer to peer groups for military

Family Fundays - These are family engagement days designed to produce a community within a community for peer support and positive interactions. These activities are designed for the whole family to participate in and allow positive interactions to occur between family members and with their peers. In 2012, we had more than 400 servicemembers, veterans, and family members participate in more than 7 Family Fundays. Some of the Family Fundays were held at theme parks, sport games, museum, and other activities.

In addition to the program costs reported here, Camaraderie Foundation received donated services for web, public relations, marketing, and design support with an estimated fair value of \$50,000 and professional video production services with an estimated fair value of \$7,000. This support enabled Camaraderie Foundation to increase the awareness of the challenges our military families face during deployments and upon reintegration while educating the target audience to the services that are available to assist them.

In 2012 an Executive Director was hired to build a team to assist the military families in need of counseling support and build a sustainable organization. In 2012 we provided nearly 70 counseling scholarships (12 sessions each), provided support for over 400 servicemembers and their families. We participated in more than 25 community events to raise awareness about the issues facing our military veterans and their families. Through these efforts, we educated more than 2,000 people and had more than 600 hours of volunteer time donated to support the efforts.

At the end of 2012, with the issuance of 70 counseling scholarships, the Board designated \$31,797 of assets to cover the cost of future counseling sessions for its clients.
