(Revenue \$ ) The Organization produced both long term and short term results for service members, veterans, and families of service members and veterans. The Organization awarded 100 private counseling scholarships (12 sessions each) to service members, veterans, and families of service members and veterans. The counseling sessions enable the participants to learn better coping mechanisms, enhance their communication skills with their family members, and build stronger family bonds. Approximately 50 percent of scholarships were awarded directly to service members and veterans across all branches of the military, 35 percent of scholarships were awarded to families of service members and veterans and 15 percent of scholarships were awarded to children of service members and veterans.

4b (Code: ) (Expenses \$ 8,777. including grants of \$ ) (Revenue \$ 0.) Family Fundays - Family Fundays are family engagement days designed to produce a community within a community for peer support and positive interactions. These activities are designed for the whole family to participate in and allow positive interactions to occur between family members and with their peers. In 2013, the Organization had more than 400 service members, veterans, and family members participate in 6 Family Fundays. Some of the Family Fundays were held at theme parks, sports games, museums, and other locations.
